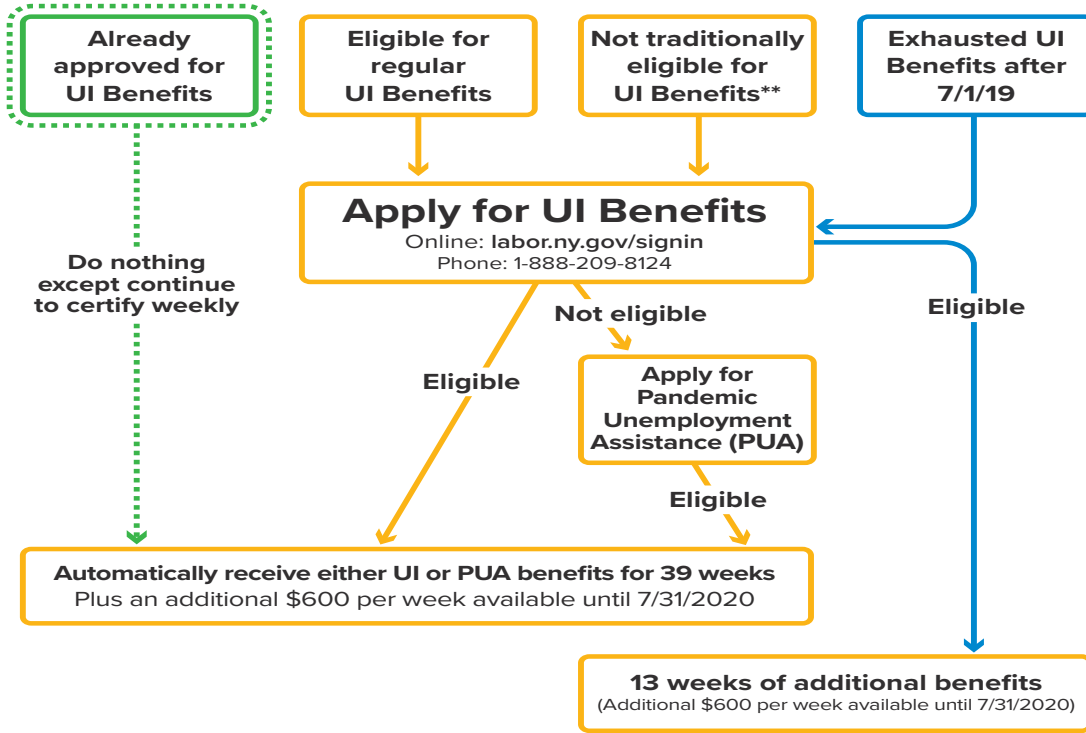

# Many Chambers, One Strong Voice

**R**ecognizing the need for a strong, streamlined, and collective voice, Rochester Chamber is excited about the newly formed "Advocacy Coalition of Rochester Area Chambers."

This collaborative alliance met for the first time in August and discussed legislative priorities, partnership opportunities, and joint advocacy days. The Finger Lakes region is wonderfully diverse and, as such, calls for a nuanced approach to effective advocacy. This new body fulfills that need and will be instrumental in amplifying the voices of our thousands of collective members.

In September we had an even larger turnout and decided to establish a more formal mission statement to keep us focused and on track. We also discussed hot topics in the news like education, Lake Ontario flooding, the striking workers bill, and broadband access.

The October meeting again brought new faces to the table along with several additional items of interest. We spent a great deal of time talking about the New York Health Act as it is expected to be a significant issue in the upcoming session.

As currently presented, the legislation would prove harmful for businesses of all sizes. Rochester Chamber CEO Bob Duffy testified before the joint Assembly and Senate Health Committee hearing in Rochester to articulate concerns expressed by chamber members and the larger business community.



Determining a list of priorities for the upcoming legislative session is critically important to ensuring the voice of Finger Lakes region business is heard loud and clear. In that spirit, the Advocacy Coalition sent out a survey to each of our respective memberships to poll which issues have the greatest impact. The survey asked employers and employees about issues ranging from early childhood development and education reform to taxes and New York State mandates.

Protecting businesses against harmful legislative overreach and suffocating policies will continue to be a chief priority of Greater Rochester Chamber of Commerce and the Advocacy Coalition of Rochester Area Chambers. So too will growing our collaborative relationships with partner organizations like Unshackle Upstate, NFIB, the Business Council of New York State, and the U.S. Chamber of Commerce.

Working together in an effort to keep New York appealing to the future workforce is crucial, and Rochester Chamber is proud to lead the way in ensuring that we have policies in place which foster that mission.

Notes from Advocacy Coalition of Rochester Area Chambers meeting:

Representatives of non-profit organizations, the City of Rochester, the County of Wayne and interested organizations gathered on February 11<sup>th</sup> to learn details from federal and state speakers about community initiatives to encourage a “full count” in the 2020 decennial census. Between April and June, census workers will visit local homes to confirm information used for apportioning congressional districts for the next 10 years as well as federal funds for schools, health care, highways, bridges and numerous human service programs. Official census workers will have personal identification when working in the community. ### **Local Technology Pulls Together to Help Miniature Donkey in Ontario**

About nine months ago, a miniature donkey by the name of Saler was born on Wychmere Farms, owned by Bob and Karen Pinkney, on Lake Rd. in Ontario, Wayne County. The donkey had trouble with the tendons in his front legs not developing as fast as the tendons in the rear legs. The front hooves were curving downward which restricted movement. Surgery was done to help relieve the tendon problem which was only partially successful.

This is where local technology came together. The process began with Lori and Dan Koonmen, friends of the Pinkney family. They would stop by and help with the rehabilitation of Saler, after surgery. Lori contacted her brother and he recommended a 3-D scan to aid in the design of special corrective shoes. Lori then contacted Harbec and talked with Matt Jewett, general manager of the company. Matt is a mentor at R.I.T. and recommended involvement of the bio-medical engineering students at R.I.T. and the FIRST Robotics Tech Challenge team from Penfield.

The R.I.T. Bio-Med students, Sean Bellefeuille and Will Byron brought the scanner to the farm, scanned the hooves and did their research on the hoof of a donkey. Consultations were held with Saler’s veterinarian and farrier. Prototypes were made and the final product was manufactured at Harbec, 358 Timothy Lane, Ontario, on a CNC machine out of aluminum. A small wedge was also designed with the shoe that will be adjusted every few days and will eventually allow the donkey’s hooves to be parallel to the ground.
